Purchasing equipment and supplies for air purification.

Staff payroll to ensure the operation of schools to reduce risk of virus transmission and exposure to environmental health hazards, and to support student health needs.

Buffalo Valley Public Schools plans to utilize ARP ESSER III funds to Prepare, Prevent, and/or Respond to the COVID 19 impact on our district. The committee recommends the following to address learning loss:

Purchasing software and curriculum for After School Program to close the gaps in student learning and learning loss caused from gaps in instruction caused by COVID 19.

Purchase hardware for using online curriculum during After School Program.

Pay Teacher stipends for after school programs.

3. How the LEA will spend its remaining ARP ESSER funds consistent with the uses authorized in section 2001(e)(2) of the ARP Act; and

Buffalo Valley Public Schools plans to utilize ARP ESSER III funds to Prepare, Prevent, and/or Respond to the COVID 19 impact on our district. The committee recommends spending the ARP ESSER III funds:

Pay salaries and benefits of teacher aides / paraprofessionals to ensure teachers have the resources needed to address the learning styles of each student.

Pay salaries and benefits of custodial and maintenance staff.

Purchasing educational tech for online learning.

Paying existing staff is necessary to maintain the operation and continuity of services.

How the LEA will ensure that the interventions it implements, including but not limited to those implemented under section 2001(e)(1) [20% set-aside], will respond to the academic, social, emotional and mental health needs of students, and particularly those students disproportionately impacted by COVID-19, including students from low-income families,

Students of Low-Socioeconomic status and Native American Students will be monitored and assessed by teachers, counselors, and administrators to identify their academic, social, emotional, and mental health needs.

District Will Address:

Academic Needs

1. Provide devices and connectivity for virtual learning as needed.
2. Implement evidence-based instruction during after school tutoring.
3. Add personnel to provide support for unfinished learning.

Social Needs

1. Engage families in the school's programs of academics and activities.
2. Expand and open new opportunities in club and group activities.
3. Provide additional nutrition as needed.

Emotional/Mental Health Needs

1. Access to external resources for more counseling opportunities for students.

Daily evaluations and observations will be conducted throughout, and student progress will be documented, and data collected to determine student response to interventions.
